**ARTS AND CRAFT INFORMATION
JURIED SHOW**

GROUNDS: Held in Bandera City Park on the banks of the Medina River.

ELIGIBILITY: Open to individual artists and craftsmen presenting their original works. No manufactured, imported or resale items will be allowed in the Arts and Craft area – only original works and prints by exhibiting artists. Demonstrating your art or craft, while not required, will be a consideration when booths are being assigned. To maintain the quality and variety of the Arts and Crafts shown, this will be a juried show. Bandera Business Association reserves the right to reject any display that is not in keeping with the examples submitted. Commercial vendors are welcome in the commercial area.

ABOUT THE JURY: A jury of Artists and Craftsmen is selected to judge the pictures and slides presented for consideration for our show. Be sure you send clear pictures that compliment your work or you may send a sample of your work to be judged.

REGISTRATION: The registration fee is \$60 per space for the one-day show. There will be no price limit on your items sold and no commission will be taken. All registration forms must be accompanied by four photographs (returned with S.A.S.E. only), and a check or money order payable to Bandera Business Association. **Your check will not be cashed until you have been accepted into the show. Deadline for application is June 4, 2010.**

SPACES: Open spaces *only* are provided and will be 10'x10'. You provide your own canopy. If you plan to use a canopy, tent, or umbrella, please specify and give dimensions. There will be a limited number of spaces available. Electricity will be available on a strictly limited basis at an additional charge of \$10 per space, and only to those *demonstrating* an art or craft.

NOTIFICATION OF ACCEPTANCE: Artists will be notified of their acceptance no later than June 11, 2010. You will receive an information packet no later than June 18, 2010. *There will be no refunds after June 11, 2010 and no refunds should bad weather occur.*
